RESOLUTIONS

1. <u>Distribution of Pension State Aid</u>

A motion was made by Mr. Celli, seconded by Mr. Barry, to adopt a Resolution, as submitted, authorizing the distribution of \$234,219.42 received in Pension State Aid for 2018 as follows: Firemen's Pension Plan \$9,368.77; Municipal Pension Plan \$131,162.88; and Police Pension Plan \$93,687.77. Therefore, \$32,199.23 is owed to the Firemen's Plan, \$88,656.12 is owed to the Municipal Employees Plan and a balance of \$408,052.23 is owed to the Police Plan. Further, it is moved that these balance be paid by the General Fund by December 31, 2018. Voice vote; all in favor. Motion carried.

1. Amend Agreement - Franklin Twp. Municipal Authority

A motion was made by Ms. Mancini, seconded by Ms. Lamenza, to amend the agreement with the Franklin Twp. Municipal Authority relative to the number of sewer tap-ins for the Rt. 288 Sewer Extension Project. Voice vote; all in favor. Motion carried.

2. <u>Sewer Tap-In – Richard Painter (Wayne Twp.)</u>

A motion was made by Mr. Barry, seconded by Ms. Mancini, to approve the sewer tap-in for Richard Painter, 645 Crabapple Lane (Wayne Twp.) (1 tap, 1, EDU, \$1,000). Voice vote; all in favor. Motion carried.

3. Insight Pipe - Sanitary Sewer Lining

A motion was made by Mr. Celli, seconded by Ms. Mancini, to approve the proposal from Insight Pipe Contracting (Harmony, PA) in the amount of \$66,390.40 (Costar pricing) for the lining of 1428 linear feet of sanitary sewers. This amount will be paid from the Sewage Collection Fund. Voice vote; all in favor. Motion carried.

4. <u>Purchase – Jib Crane</u>

A motion was made by Mr. Barry, seconded by Ms. Lamenza, to ratify the purchase of a jib crane from Material Handling Solutions (Mission, Tx) in the amount of \$15,525. This amount will be paid from the 2016 Bond Issue. Voice vote; all in favor. Motion carried.

Parks/Recreation: (Mancini, Guerrera, Celli)

1. Shelter Refund Policy

A motion was made by Mr. Barry, seconded by Ms. Guerrera, to adopt a park shelter refund policy, as submitted. Voice vote; all in favor. Motion carried.

A motion was made by Ms. Mancini, seconded by Mr. Celli, to authorize the employment of Samuel Barry as a part-time Laborer III at the rate of \$15.00 per hour. Roll call vote. All in favor, except Mr. Brough and Ms. Guerrera. Mr. Barry abstained.

3. <u>Advertise Ordinance – Police Pension Plan</u>

A motion was made by Mr. Barry, seconded by Mr. Celli, to advertise an amendment to the Police Pension Plan, specifically the definition of "Normal Retirement Age" and eligibility requirements under the Deferred Retirement Option Plan (DROP). Voice vote; all in favor. Motion carried.

4. <u>Employment – Brian Partridge, Troy Follett, Corey Bailey (Part-Time</u> Firefighters)

A motion was made by Ms. Mancini, seconded by Mr. Barry, to authorize the employment of Brian Partridge, Troy Follett and Corey Bailey as part-time firefighters at the rate of \$15.00 per hour. All in favor. Motion carried.

5. <u>Anti-Nepotism Policy</u>

A motion was made by Ms. Guerrera, seconded by Mr. Brough, to adopt an Anti-Nepotism Policy, as submitted. This policy would be effective 1/1/19.
