2. <u>Memorial Day Parade; EC Parade Committee – Halloween & Christmas Parades; EC Area Chamber of Commerce - "Let There Be Lights"; EC Area Chamber of Commerce - Fall Fest</u>

A motion was made by Ms. Dici, seconded by Ms. Lamenza, to approve the following:

- the request by the Memorial Day Parade Committee to hold the Memorial Day Parade on Monday, May 29 beginning at 10:00 a.m. and to use the parking area near Todd Avenue as a staging area. It is also requested to use Circle Playground for a community cookout
- the request by the EC Parade Committee to hold the Halloween Parade on October 28 at 3:30pm and the Christmas Parade on December 2 at 3:30pm
- the request by the EC Area Chamber of Commerce to hold a "Let There Be Lights" event, December 1 from 6pm 8pm on Lawrence Avenue. Further, it is requested to close Lawrence Avenue from 4<sup>th</sup> Street to 6<sup>th</sup> Street for this event.
- the request by the EC Area Chamber of Commerce to hold a Fall Fest, September 30 from 11am 5pm on Lawrence Avenue. Further, it is requested to close Lawrence Avenue from 4<sup>th</sup> Street to 10<sup>th</sup> Street for this event.

# 6. <u>Use Shooting Range – 1x Exception</u>

At the Regular Meeting of Council held 9/19/16, Council voted to discontinue the shooting range at Stiefel Park, effective 12/31/16, to be in compliance with the Master Park Plan. However, a motion was made by Ms. Dici, seconded by Mr. Ovial, to make a one-time exception to use the shooting range in Stiefel Park to qualify one of the newly hired part-time officers (Gary Greene, Jr.). Voice vote; all in favor. Motion carried.

1. Travel Request – Electric Department Personnel

A motion was made by Mr. Celli, seconded by Mr. Ovial, to approve the travel request from the Electric Department personnel as follows:

The cost to attend this training in Columbus, OH is \$1619.90 each including registration and hotel. These amounts will be paid from the Electric Fund. Voice vote; all in favor. Motion carried.

  A motion was made by Mr. Celli, seconded by Mr. DeCaria, to reject all bids for the Public Works Building Demolition Project and to authorize Frank B. Taylor Engineering to rebid the project. Voice vote; all in favor. Motion carried.
- 3. <u>2017 Street Paving Program Advertise</u>

A motion was made by Ms. Lamenza, seconded by Ms. Mancini, to authorize Frank B. Taylor Engineering to prepare/advertise specifications for the 2017 Street Paving Program. Voice vote; all in favor. Motion carried.

4. <u>Moody & Associates</u>

A motion was made by Mr. Celli, seconded by Ms. Mancini, to approve the payment schedule, as submitted, from Moody and Associates (Meadville, PA) for the underground storage tank corrective action work. These amounts will be paid from the 2016 Bond Issue. Voice vote; all in favor. Motion carried.

5. <u>Agreement – The Municipal Authority of the Township of Franklin</u>
A motion was made by Ms. Dici, seconded by Mr. DeCaria, to approve the Agreement, as submitted, with the Municipal Authority of the Township of Franklin relative to the sewer tap in fees for their Route 288 Sewer Extension Project. Voice vote; all in favor. Motion carried.

### Parks/Recreation: (DeCaria, Mancini, Dici)

1. Boy Scout Troop #806; Ellwood City Soccer; Ellwood City Area Historical Society; EC Community Enrichment Concert Series; Christmas in the Park; Octoberfest (Wolves Club/Rotary/Lion's Club)

A motion was made by Mr. DeCaria, seconded by Mr. Celli, to approve the following:

- the request by Boy Scout Troop #806 to camp out in Ewing Park as part of the Earth Day celebration. They are requesting the use of shelter #8 on April 21 & 22.
- the request by EC Soccer to use the soccer field in Stiefel Park March 20, 23, 27, 30; April 1,3,6,8,10,13,17,20,24,28; May 1,4,8,11,15,18,22,25,29
- the request by the Ellwood City Area Historical Society to use shelter #8 on September 11
- the request by the EC Community Enrichment to hold the 2017 Summer Concert Series at the Community Plaza June 17, 24, July 8, 15, 29 and August 9 & 19 at 7pm. It is further requested to close Beaver Avenue AND Lawrence Avenue from 5<sup>th</sup> to 6<sup>th</sup> Street for these concerts.

- the request by the Christmas in the Park Committee to use Ewing Park from November 1 – January 5 for their annual event. The actual event runs December 2-27
- the request by the Wolves Club/Rotary/Lion's to use shelters #2A/2B, #3, #3A and #4 on October 7 from 12-5:30pm for an Octoberfest celebration featuring homemade brews to raise money for charitable purposes and to suspend Part 10, Chapter 1066, subsection 1066.03 (a) of the Codified Ordinance Book pertaining to the prohibition of alcohol in Ewing Park. This suspension only applies to participants of the Octoberfest held by the Wolves Club/Rotary/Lion's. Event insurance shall be purchased by the Wolves Club/Rotary/Lion's, naming the Borough of Ellwood City as an additional named insured. All necessary State and County permits shall be in place for this event.
