## Health/Public Safety: (Dici, Celli, Lamenza)

1. Payment – Glick Fire Equipment Co. \$14,172.85

A motion was made by Ms. Mancini, seconded by Mr. Ovial, to approve the payment in the amount of \$14,172.85 to Glick Fire Equipment Co. for the repair of the 2006 Spartan (fire truck). This amount will be paid from the General Fund. Voice vote; all in favor. Motion carried.

# Public Works/Utilities: (Celli, Dici, Lamenza)

1. Agreement – Southwestern PA Commission (Sinc-Up Project)
The Borough applied to Southwestern Pennsylvania Commission's (SPC)
Regional Traffic Signal Program for signal equipment upgrades and signal coordination. The Borough met with SPC to finalize scope and costs. The estimated cost for the project is \$197,906.92, broken up as \$158,325 Federal Share and \$39,582 local share (Ellwood City). Therefore, a motion was made by Mr. Celli, seconded by Ms. Mancini, to allow Ellwood City Borough to execute an Agreement with SPC for the "Ellwood City Sinc-Up Project". This amount would be paid from the General Capital Reserve Fund. Voice vote; all in favor. Motion carried.

2. <u>Bronder Technical Services – Traffic Signal Maintenance</u>

A motion was made by Mr. Celli, seconded by Mr. Ovial, to approve the traffic signal maintenance agreement with Bronder Technical Services in the amount of \$1750 annually. This amount will be paid from the General Fund. Voice vote; all in favor. Motion carried.

# Parks/Recreation: (DeCaria, Mancini, Dici)

1. <u>EC Cheerleaders, Angelman Syndrome Foundation, EC Fastpitch, Boy Scouts, Lions Club Shelter Request</u>

A motion was made by Mr. DeCaria, seconded by Ms. Dici, to approve the following:

- the request by the Ellwood City Cheerleaders to hold a 5K run/walk in Ewing Park on June 25 beginning at 9am. They are also requesting use of the Folino Stage.

1. <u>Employment – Lineman III</u>

A motion was made by Ms. Dici, seconded by Ms. Lamenza, to authorize the hiring of Levi Marburger as a Lineman III at the rate of \$19.12/hour, contingent upon successful completion of all background checks and certifications. Voice vote; all in favor. Motion carried.
