Voice vote; all in favor. Motion carried.

2. <u>Satisfy Bond Issue for Veterans Memorial Swimming Pool</u>

A motion was made by Ms. Mancini, seconded by Mr. Ovial, to notify the Bond Underwriter (Janey, Montgomery, Scott) of the Borough's intent to satisfy the Bond Issue for the Veterans Memorial Swimming Pool. Voice vote; all in favor. Motion carried.

#### Health/Public Safety: (Dici, Celli, Lamenza)

1. Agreement – "Buckle Up PA" Project

A motion was made by Ms. Dici, seconded by Ms. Mancini, to approve the Agreement with the North Central Highway Safety Network, Inc. with regard to the "Buckle Up PA Project" whereas the Police Department will be responsible to carry out enforcement, public awareness, and education and must contribute at least 10% of in-kind services for this cost reimbursement grant. Voice vote; all in favor. Motion carried.

2. <u>Lincoln High School – close Wolverine Way (Wellness Fair)</u>

A motion was made by Ms. Dici, seconded by Mr. Ovial, to approve the request by Lincoln High School to close Wolverine Way from the school parking lot to Short Street on May 13 from 8am-11am. Voice vote; all in favor. Motion carried.

3. <u>Memorial Day Parade</u>

A motion was made by Mr. Celli, seconded by Ms. Lamenza, to approve the request by the Memorial Day Parade Committee to hold the Memorial Day Parade on Monday, May 30 beginning at 10:00 a.m. and to use the parking area near Todd Avenue as a staging area. Voice vote; all in favor. Motion carried.

### Public Works/Utilities: (Celli, Dici, Lamenza)

1. <u>ExteNet Systems, Inc.</u>

A motion was made by Mr. Celli, seconded by Mr. Ovial, to approve the request by ExteNet Systems, Inc. to install wireless telecommunications equipment on existing wooden utility poles within public rights-of-way located at 601 Hazel, 415 Bridge, 213 Hazel, 212 North, Union/Ellwood. Voice vote; all in favor. Motion carried.

### 2. <u>County Aid Request - \$20,800 (Concrete)</u>

A motion was made by Mr. Celli, seconded by Ms. Dici, to request County Aid in the amount of \$20,800 to resurface the concrete section of street located at 6<sup>th</sup> Street/Glen Avenue. Voice vote; all in favor. Motion carried.

#### 3. <u>2016 Street Paving Program - Advertise</u>

A motion was made by Mr. Celli, seconded by Ms. Lamenza, to authorize Frank B. Taylor Engineering to prepare/advertise specifications for the 2016 Street Paving Program. Voice vote; all in favor. Motion carried.

# 4. <u>Sixth Street Regulating Station</u>

A motion was made by Ms. Dici, seconded by Mr. DeCaria, to authorize the Electric Department to relocate the Sixth Street regulating station to a pole mounted configuration at 6<sup>th</sup> Street/Glen Avenue.

#### Parks/Recreation: (DeCaria, Mancini, Dici)

1. <u>EC Area Historical Society, Ewing Park-a-Palooza, Lincoln High School Class of</u> 2016

A motion was made by Mr. DeCaria, seconded by Mr. Celli, to approve the following:

- the request by the Ellwood City Area Historical Society to use Shelter #8 on September 12.
- the request by the Ellwood City Area Chamber of Commerce to host the "Ewing Park-a-Palooza" on May 16 from 7a-4p utilizing shelters, restrooms and other structures for various events.
- the request by the Lincoln High School Class of 2016 to use Shelter 2A/2B on May 25 from 10a-2p.

Voice vote; all in favor. Motion carried.

# Administration/Personnel: (Lamenza, Celli, Ovial)

1. <u>2016 Part-time Employees' Wage Rate (Firefighters)</u>

A motion was made by Ms. Dici, seconded by Ms. Lamenza, to establish the wage for part-time Firefighters retroactive to the first pay in January, 2016 as follows:

<sup>\*</sup> Longevity paid at \$25/year of service payable to firefighters who worked at least 300 hours in previous year (Gross Pay ÷ Avg. Rate of \$10/hour = # of Hours) to be paid with the first pay in December of current year.

# 2. **Rescind** - 2016 Wage – Non-Union Full-Time (Wastewater Treatment Plant Manager)

A motion was made by Mr. Celli, seconded by Mr. Ovial, to <u>rescind</u> the motion made at the Regular Council meeting dated 2/15/16 whereby the wage for the Wastewater Treatment Plant Manager was established at \$21.367/hour and the salary at \$44,443, retroactive to the first pay in January, 2016. Voice vote; all in favor. Motion carried.

3. <u>2016 Wage – Non-Union Full-time (Wastewater Treatment Plant Manager)</u>
A motion was made by Mr. Ovial, seconded by Ms. Lamenza, to establish the wage for the Wastewater Treatment Plant Manager, retroactive to the first pay in January, 2016 as follows:

Wastewater Treatment Plant Manager \$29.471/hr. \$44,443 salary

Voice vote; all in favor. Motion carried.

### 4. <u>2016 Employee Hourly Billing Rates</u>

A motion was made by Mr. Ovial, seconded by Ms. Lamenza, to establish the 2016 employee hourly billing rates with an overhead factor (multiplier) calculated at 1.5 as follows:

# 7. <u>2016 IRS Mileage Reimbursement</u>

A motion was made by Ms. Mancini, seconded by Ms. Dici, to adopt the 2016 IRS Mileage Reimbursement Rate of 54 cents per mile. Voice vote; all in favor. Motion carried.

# 8. **Revised** Pension Benefit – Brian Damon

A motion was made by Ms. Dici, seconded by Ms. Mancini, to approve the **revised** monthly disability pension benefit for Brian Damon in the amount of \$4,417.63, retroactive to 1/1/16, as submitted by the Actuary. This amount will be paid from the Police Pension Plan. Voice vote; all in favor. Motion carried.
