#### **ORDINANCES**

#### 1. 2016 Bond

A motion was made by Mr. Ovial, seconded by Mr. Celli, to adopt an ordinance, as submitted, authorizing and directing the issuance of its General Obligation Bonds, Series of 2016 in an aggregate principal amount of \$7,080,000 pursuant to the Act of the General Assembly of the Commonwealth of Pennsylvania, known as the Local Government Unit Debt Act, determining that such debt shall be nonelectoral debt of the local government unit; authorizing the acceptance of a proposal for the purchase of the bonds, and setting forth related provisions; providing that such General Obligation Bonds, when issued, shall be general obligations of the local government unit; fixing the substantial form, denominations, numbers, date, maturity dates, yields, interest rates, interest payment dates, registration provisions, place of payment of principal, maturity amount and interest; authorizing execution of such bonds and authentication thereof; providing covenants related to payment of debt service and pledging the full faith, credit and taxing power of the local government unit in support thereof; creating a sinking fund and a clearing account; appointing agents and professionals; authorizing and directing specified officers of the local government unit to do, to take and to perform certain specified, required, necessary or appropriate acts and things; ratifying prior advertisement and directing further advertisement; authorizing payment of expenses; ratifying the preliminary Official Statement; authorizing approval of the final Official Statement; providing covenants related to continuing disclosure and compliance with provisions of the Internal Revenue Code; and repealing all ordinances or parts of ordinances insofar as the same shall be inconsistent herewith. Roll call vote. All in favor, except Ms. Dici and Ms. Mancini. Motion carried, 5-2.

#### 2. <u>2017 Bond</u>

A motion was made by Ms. Lamenza, seconded by Mr. Ovial, to adopt an ordinance, as submitted, authorizing and directing the issuance of its General Obligation Bonds, Series of 2017 in an aggregate principal amount not to exceed \$4,995,000 pursuant to the Act of the General Assembly of the Commonwealth of Pennsylvania, known as the Local Government Unit Debt Act, determining that such debt shall be nonelectoral debt of the local government unit; inviting a proposal for the purchase of such bonds, and setting forth related provisions; providing that such general obligation bonds, when issued, shall be general obligations of the local government unit; fixing the substantial form, denominations, numbers, date, maturity dates, maximum yields, maximum interest rates, interest payment dates, registration provisions, place of payment of principal, maturity amount and interest; authorizing execution of such bonds and authentication thereof; providing covenants related to payment of debt service and pledging the full faith, credit and taxing power of the local government unit in support thereof; creating a sinking fund and a clearing account; appointing agents and professionals; authorizing and directing specified officers of the local government unit to do, to take and to perform certain specified, required, necessary or appropriate acts and things; ratifying prior advertisement and directing further advertisement; authorizing payment of expenses; ratifying the preliminary Official Statement; authorizing approval of the final Official Statement; providing covenants related to continuing disclosure and compliance with provisions of the Internal Revenue Code; and repealing all ordinances or parts of ordinances insofar as the same shall be inconsistent herewith. Roll call vote. All in favor, except Ms. Dici and Ms. Mancini. Motion carried, 5-2.

1. <u>Grant Application – Lining of Sanitary Sewer Lines (Commonwealth Financing Authority)</u>

- 2. Rescind PennDot Reimbursement 75% SR65 Project (Second St to Woodside Avenue)
  A motion was made by Mr. Celli, seconded by Mr. Ovial, to **rescind** Resolution #201610 adopted at the Regular Council Meeting held 9/19/16 authorizing the submission to
  PennDot to provide at 75% reimbursement for costs incurred in adjusting our manholes
  affected by Project SR65, Section L28 (Second Street to Woodside Avenue). Voice vote;
  all in favor. Motion carried.
- 3. <u>Agreement PennDot SR65 Project (Second St to Woodside Avenue)</u>
  A motion was made by Mr. Celli, seconded by Ms. Mancini, to authorize the Borough Manager to sign any and all documents relative to PennDot's SR65, Section L28 (Second Street to Woodside Avenue) Project. Voice vote; all in favor. Motion carried.

# 4. <u>Distribution of Pension State Aid - 2016</u>

A motion was made by Mr. Celli, seconded by Ms. Lamenza, to adopt a Resolution, as submitted, authorizing the distribution of \$205,608.37 received in Pension State Aid for 2016 as follows: Firemen's Pension Plan \$8,749.29; Municipal Pension Plan \$118,115.45; and Police Pension Plan \$78,743.63. Therefore, \$24,964.71 is owed to the Firemen's Plan, \$45,341.55 is owed to the Municipal Employees Plan and a balance of \$345,828.37 is owed to the Police Plan. Further it is moved that these balance be paid by the General Fund by December 31, 2016. Voice vote; all in favor. Motion carried.
