# Finance: (Guerrera, Cragle, Barry)

1. 2021 IRS Mileage Reimbursement Rate – 56 cents per mile

A motion was made by Ms. Lamenza, seconded by Ms. Dici, to adopt the 2021
IRS Mileage Reimbursement Rate of 56 cents per mile. Voice vote; all in favor.
Motion carried.

- 2. <u>2021 Monthly Transfer \$120,833.33 to General Fund from Electric Fund</u>
  A motion was made by Mr. Barry, seconded by Ms. Lamenza, to approve the 2021 monthly transfer in the amount of \$120,833.33 to the General Fund from the Electric Fund. Roll call vote; all in favor. Motion carried.
- 3. <u>Transfer \$47,862 to Electric Capital Reserve from Electric Fund</u>
  The Electric Usage Sold in 2020 was 47,862,013 kwh. Borough Ordinance #2211, Section 38: **Purchase Power Adjustment** states that one mill (.001) per kilowatt hour is charged for the purpose of capital improvements. Therefore, a motion was made by Mr. Barry, seconded by Mr. Cragle, to transfer \$47,862 to the Electric Capital Reserve Fund from the Electric Fund. This entry shall be reflected on the books for 2020. Roll call vote, all in favor. Motion carried.

### 4. Donation – Ellwood City Area Historical Society

A motion was made by Mr. Barry, seconded by Ms. Lamenza, to authorize the one time donation in the amount of \$5,000 to the Ellwood City Area Historical Society. This amount will be paid from the L&N Property Fund and shall only be used for the acquisition, restoration, and maintenance of historical properties.

After a discussion, Ms. Lamenza withdrew her second.

A motion was made by Mr. Cragle, seconded by Ms. Dici, to postpone this item until the February meeting. Roll call vote. All in favor, except Mr. Barry. Motion carried, 6-1.

1. Advertise Bids – Refuse, Recycling, Yard Waste Collection

A motion was made by Mr. Brough, seconded by Ms. Dici, to advertise bids for the collection of refuse, recycling, and yard waste. Voice vote; all in favor. Motion carried.

# 2. <u>Purchase – Hot Box/Reclaimer</u>

A motion was made by Mr. Brough, seconded by Mr. Cragle, to authorize the purchase of a hot box/reclaimer from Seal Master in the amount of \$28,230 (Costar pricing). This amount will be paid from the General Fund. Roll call vote; all in favor. Motion carried.

1. Ellwood City Fastpitch

A motion would be in order to approve the request by the EC Fastpitch to use Merit Book Park and the Women's Field at Stiefel Park, Mondays – Sundays, June 1 – October 31. This item died for the lack of a motion.

## 2. Ellwood City Girls Softball

A motion was made by Mr. Cragle, seconded by Mr. Brough, to approve the request by the EC Girls Softball to use the Girls field at Stiefel Park, February – November, Mondays -Fridays, 4-10pm and the SW corner of the Soccer Field, February – November, Tuesdays and Thursdays, 4-9pm. Voice vote; all in favor. Motion carried.
